

## **PRIVACY POLICY**

On May 25, 2018 the EU Regulation 2016/679 becomes fully effective, otherwise known as GDPR (General Data Protection Regulation), which contain the new provisions concerning privacy (document here: <https://www.eugdpr.org/>).

This document will describe the management arrangements for the processing of personal data of user which visit @Cult web site.

The information provided only applies to our website and does not concern any websites that may be visited by a user via external links, nor other websites.

## **DATA CONTROLLER**

As a consequence of the use of the Web Site, personal information concerning identified or identifiable people might be collected and processed.

The data controller is the company @CULT SRL, which is located in Rome (Italy), Via Quintino Sella 33, 00187

## **PLACE WHERE DATA IS PROCESSED**

The processing data related to the web-services of this web site shall take place at the same office mentioned above and they are treated only by the staff involved and authorized.

No data may disclose to third parties.

## **CATEGORIES OF PROCESSED DATA**

### *Navigation data*

The computer systems responsible for operation of the Site may acquire during their normal operation some personal data.

This information is not gathered to be associated with the identified interested party, but because of their own nature they could enable the identification of the users through elaboration and association with data kept by third parties (e.g.: IP addresses and/or other parameters referring to the operating system and computer environment of the users).

Such data are used solely for the purpose of ensuring the proper functioning of the site and deriving anonymous statistical information concerning use of the site; the data could be used to establish liability assessments in case of computer crimes committed against the website.

### *Data provided voluntarily by users*

The optional, explicit and voluntary sending of electronic email to the addresses listed on our sites involves the subsequent acquisition of sender's addresses necessary in order to reply to the requests and also any other personal data contained in the message.

Specific summaries will be progressively provided or visualized in the site's pages prepared for particular services which may be required (the forms for sending CVs or to request detailed information on @CULT SRL products / services).

### *Cookies*

This web site does not intentionally collect any personal data about users.

Cookies are not used for transmission of information of personal nature, neither the use of c.d. persistent cookies of any type or rather user's tracing systems.

Use of the so-called session cookies is strictly linked to the transmission of session identifiers necessary for allowing a safe and efficient exploration.

### **OPTIONAL DATA PROVISION**

Apart from that specified for navigation data, the user is free to provide personal data when required in specific session of the site to request informative material or any other communications.

### **DATA PROCESSING METHODS**

The collected data will be treated with Electronic instruments. Specific safety measures are in place to prevent loss of data, illegal or improper use and unauthorized access (such as the SSL security certificate). The data will not be disclosed to third parties other than the holder.

### **DATA SUBJECT RIGHTS**

The subjects to whom the personal data refer are entitled to receive, at any time, confirmation of the existence or non-existence of the data, information on the content and origin, to verify the correctness of the data or request data integration, update or correction.

They also have the right to request the cancellation, the transformation into an anonymous form or the block of processed data treated in violation of the law, and to oppose in any case, for legitimate reasons, to its treatment.
